DIRECTIONS TO SHOW SITE

From the North on Interstate 75:

South to the Route 63 (Exit 29). Go west on Rt. 63 to Rt. 4. Go South on Rt. 4 to Liberty-Fairfield Rd. Turn right on Liberty-Fairfield (stoplight and a Shell Station at the intersection) Cross over the river & turn left onto Augspurger Road. Just before the railroad tracks, turn right onto Gephard Road. Go up the hill, the show site is on the left.

From the South on I-75 and either direction on I-71:

Take I-275 West. Exit at the Hamilton-Fairfield ramp, (Route 4). Turn right to ByPass Rt. 4. Stay on it until it reaches Route 4 again at traffic light. Turn right onto Route 4. Turn left at Liberty-Fairfield (stoplight and a Shell Station at the intersection). Cross over river. Turn left onto Augspurger Road. Just before the railroad tracks turn right onto Gephart Road. Go up the hill, the show site is on the left.
