WC Test:

- 1) Back to back singles in water (ducks) to prove willingness to re-enter the water.
- 2) A land single retrieve of 50 yards in light cover (chukar).
- 3) The dog is not required to be steady or deliver to hand. The judge may designate an area for delivery.
- 4) The dog should not be gun shy.

Times:

Water retrieving tests will be run beginning at 11:00 am, on Thursday, May 13, 2010. Please arrive ½ hour early for judge's instructions. Only dogs that pass the water test will be permitted to run the land retrieves. Land retrieving tests will be run immediately following completion of water tests.

Bitches in season will be allowed to run at the end of the running order. Please notify the Field Marshall, Dan Couch, upon arrival.

The owner of any dog successfully completing the test will receive a qualifying ribbon, and will be provided instructions and the documents necessary to obtain an official LRC, Inc. Working Certificate

DIRECTIONS TO TEST SITE

From the North on Interstate 75:

South to the Route 63 (Exit 29). Go west on Rt. 63 to Rt. 4. Go South on Rt. 4 to Liberty-Fairfield Rd. Turn right on Liberty-Fairfield (stoplight and a Shell Station at the intersection) Cross over the river & turn left onto Augspurger Road. Just before the railroad tracks, turn right onto Gephart Road. Go up the hill, the show site is on the left.

From the South on I-75 and either direction on I-71:

Take I-275 West. Exit at the Hamilton-Fairfield ramp, (Route 4). Turn right to ByPass Rt. 4. Stay on it until it reaches Route 4 again at traffic light (see map). Turn right onto Route 4. Turn left at Liberty-Fairfield (stoplight and a Shell Station at the intersection). Cross over river. Turn left onto Augspurger Road. Just before the railroad tracks turn right onto Gephart Road. Go up the hill, the show site is on the left.
