**ENTRY FEES:**

\$26 for the first entry of each dog, and \$19 for the additional entry of the same dog. A Recording Fee of \$3.00 will be required for each dog entered at a rally event. This fee is to be collected by the show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, this fee is to be collected for each entry.

**CLOSING DATE: 12 Noon, Wednesday, April 21, 2010**, at the Show Secretary's address, after which time entries cannot be accepted, canceled, changed, substituted, corrected, completed or signed, except as provided for in Chap. 11, Sec. 6 of AKC Rules, and no entry fee will be refunded. **TELEPHONE, TELEGRAPH, DIRECT FAX AND UNSIGNED ENTRIES CANNOT BE ACCEPTED.** Any class changes or cancellations must be received in writing prior to the closing. **Refund will be made after the show.** Entries not on official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on reverse side of the official AKC Entry Forms are not acceptable. Please notify Secretary if Acknowledgment is not received within a reasonable time.

**PRIZES, TROPHIES, CERTIFICATES AND ROSETTES** will be awarded in the ring to the person exhibiting the dog, who shall be considered the owner or agent. All claims to prizes must be made in the judging ring before completion of judging of the class, and the Show Secretary advised at once of any discrepancy.

**SHOW WILL OPEN** from 7 A.M.- 7 P.M Saturday.

Dogs may arrive at any time prior to judging. Dogs not needed for further judging will be excused. Judges are not required to wait for dogs. Dogs will not be permitted to run free on the grounds.

**USERS OF OVERNIGHT DELIVERY SERVICES:**

If you don't sign the signature waiver, your entry could be delayed, since the Show Secretary is not available at all times during the day to sign receipts. If you want to know it got there, include with your entries, a stamped, self-addressed envelope or post card which will be mailed back to you.

**Underpayments** are under AKC rules – you must make them good.

#### AGREEMENT

I (we) acknowledge that the "Rules Applying to Dog Shows" and the "Rules Applying to Registration and Discipline" and, if this entry is for an obedience trial the "Obedience Regulations," have been made available to me (us), and that I am familiar with their contents. I (we) agree to hold the AKC and any AKC approved judge harmless from any legal claim resulting from said AKC judge's action under the AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned or by the negligence of any other person, or any other cause or causes.

#### INSTRUCTIONS

1. (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 inches, over 13 inches, but not exceeding 15 inches), Dachshunds (longhaired, smooth, wirehaired), Collie (rough, smooth), Bull Terriers (colored, White), Manchester Terriers (standard, top), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record and dogs which according to their owners (records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Bred competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog. i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for the show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC (For complete rule refer to chapter 15, Section 3.)

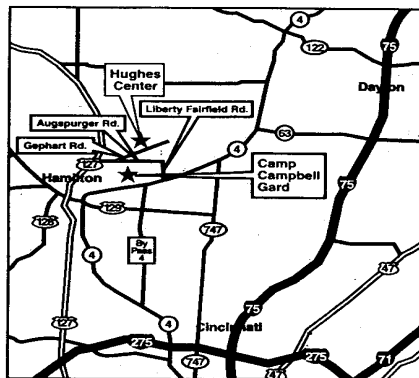
**DIRECTIONS TO SHOW SITE**


**From the North on Interstate 75:**

South to the Route 63 (Exit 29). Go west on Rt. 63 to Rt. 4. Go South on Rt. 4 to Liberty-Fairfield Rd. Turn right on Liberty-Fairfield (stoplight and a Shell Station at the intersection) Cross over the river & turn left onto Augspurger Road. Just before the railroad tracks, turn right onto Gephart Road. Go up the hill, the show site is on the left.

**From the South on I-75 and either direction on I-71:**

Take I-275 West. Exit at the Hamilton-Fairfield ramp, (Route 4). Turn right to ByPass Rt. 4. Stay on it until it reaches Route 4 again at traffic light (see map). Turn right onto Route 4. Turn left at Liberty-Fairfield (stoplight and a Shell Station at the intersection). Cross over river. Turn left onto Augspurger Road. Just before the railroad tracks turn right onto Gephart Road. Go up the hill, the show site is on the left.
